ANNUAL AND EXTRAORDINARY ASSEMBLIES 2021

The Extraordinary Assembly was held on August 21th in virtual mode due to COVID-19 pandemic, using GotoMeeting platform. The main issues approved were: i) A report on the integration process of the regional pharmaceutical forums to the International Pharmaceutical Federation. ii) The extension of the appointment for one more year of three Executive Committee positions for the 2021-2022 period: President, Director of Pharmaceutical Education and Director of Pharmaceutical Practice. iii) The analysis of the mechanisms for identifying needs and communication between the Executive Committee and the member organizations to establish new strategies for increasing communication and collaboration. The Ordinary Assembly was held on November 20 th, in virtual mode due to COVID-19 pandemic, using GotoMeeting platform. The main issues approved were: i) The action plan and the budget for the period 2021-2022. ii) A report on the ongoing process for the incorporation of the regional pharmaceutical forums into the organizational structure of the FIP.

Ten pharmacists completed the certification program as trainers for the American Pharmacists Association Pharmacy-Based Delivery of Immunizations Program. This will help train other pharmacists in the region to promote the provision of immunization services from the pharmacy.

- The second Edition of Virtual course: Formulation and execution of pharmaceutical intervention projects (June 21th to November 7th, 2021).

PROJECT FUNDING

1)Two grants -US\$ 2,500 each- were approved to partially support the following projects in the 2021-2022 period: a) Health Self-Care Schools. (Costa Rica). Project execution dates are: from June 1st, 2022 to May 31st, 2023. b) Development of pharmaceutical services in immunization against the influenza virus in community pharmacies in Uruguay (Uruguay). Project execution dates are: June 1st, 2022 to September 30th, 2023.

- 2) An additional grant was approved in the amount of US\$ 2.500 to the Pan American Conference on Pharmaceutical Education for their project: Support for the development of interprofessional education in schools and Pharmacy. Faculties of the Region of the Americas as a strategy for pharmacist training. Project execution dates are: June 1st, 2022 to May 31 st, 2023.
- **3)** With the collaboration of the Latin American Industry of Responsible Self-Care (ILAR), formed a technical advisory group to evaluate and promote the participation of the pharmacists in self-care and self-medication. As part of the work of this group, an additional call for projects in the area of self-care and self-medication.
